Supporting Opportunities for Ugandans to Learn (S.O.U.L.) Foundation's mission is to foster sustainable and vibrant Ugandan communities through unique partnerships focused on education, women's empowerment, food security, and maternal health. In the fiscal year ending 8/31/21, S.O.U.L. continued its Covid relief program. S.O.U.L.'s tailoring course with 53 women participants stitched 9,951 masks to distribute to Ugandan families, front line workers and women working in the local markets. 13 of those participants graduated from S.O.U.L.'s tailoring program. S.O.U.L. had 208 Antenatal Education Class Participants (AEC). 521 women received ultrasound scans, 600 birthing kits were distributed, and 1,900 women received prenatal vitamins. S.O.U.L.'s computer program had 60 participants. Through S.O.U.L.'s phenomenal education program, 142 primary students attended one of two pre-primary schools, and 327 students from primary to university took part in the student sponsorship program. Also, in partnership with the Ugandan Support from Diaspora (USD) S.O.U.L. facilitated an online mentorship session supporting 102 secondary level 2 students.
